THIS PRICE LIST APPLIES TO CLIENTS, SUPPLIERS AND BUSINESS PARTNERS (hereinafter: "Clients") OF THE COMPANY FORTIS PROJEKT INC.

Payment currency is Croatian kuna (HRK).

Account number (IBAN) can be obtained through the accounting department of Fortis Projekt Inc.

Fortis Projekt shall issue invoices for the services specified in this Price List. All invoices shall be issued in the written form.

Value Added Tax (VAT) is not included in the prices listed in the Price List. Clients which are not exempt from payment of Value Added Tax (VAT) in accordance with VAT Law and Rulebook will be charged at VAT rate prescribed by law.

Payment shall be made within 30 days from issuing the invoice. Default interest shall be charged for delayed payments in accordance with the applicable law. All disputes between Clients and Fortis Projekt regarding charges shall be resolved before the competent court in Zagreb.

Fortis Projekt may require payment security instrument from the Clients.

It shall be considered that Clients who require and utilize Fortis Projekt services accept all conditions of this Price List.

This Price List is valid until revocation.

Fortis Projekt has the right to alter this Price List at any time with the obligation to inform the Users on its website.

Fortis Projekt Price List applies from 1 August 2020.

## PRICES FOR OPTIC FIBERS LEASE SERVICES

Prices for one pair of optic fibers lease services are listed in the following table - prices are valid if the Contract is concluded without mandatory duration period:

Amount of monthly fee for one pair of optic fibers lease services is calculated in the cumulative manner, depending on the length of the respective optic fibers pair (N) and applying prices stipulated in the table from this article in the following manner:

- Where optic fibers are shorter or equal to 500 metres, monthly fee for lease of one pair of optic fibers amounts to 15.000 kn or 10.000 kn (B), depending on the Contract type (Contract with or without mandatory duration period of 12 months).
- Where optic fibers are longer than 500 metres but also shorter or equal to 10.000 metres, monthly fee for lease of one pair of optic fibers is calculated by means of the following formula:  $B + (N-500)*C$ .
- Where optic fibers are longer than 10.000 metres, monthly fee for lease of one pair of optic fibers is calculated by means of the following formula:  $B + 9.500*C + (N-10.000)*D$ .
